## **ORDINANCE 0-2007-21**

## AN ORDINANCE ADOPTING THE TEMPORARY APPROPRIATIONS FOR 2008 AND DECLARING AN EMERGENCY.

**WHEREAS**, the Village Council wishes to establish Temporary Appropriations for 2008 so that expenses can be met; and

**WHEREAS**, the books for 2007 are not closed as yet and the carryover amounts are not known; and

**NOW THEREFORE BE IT ORDAINED** by the Council of the Village of Windham, Portage County, Ohio, with at least two-thirds of the members thereto concurring that:

**SECTION 1**: The temporary appropriations for 2008 total \$1,935,932.00 as shown on the back of this sheet.

**SECTION 2**: That this Ordinance is hereby declared an emergency measure becoming immediately effective upon passage by Council and approval by the Mayor because it will enable the necessary temporary appropriations to be entered into the system for 2008 and ensuring the welfare of the citizens of the Village of Windham, Ohio, and to further insure the effective operation of the village.

**SECTION 3**: It is hereby found and determined that all formal actions of this council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including §121.22 of the Revised Code of the State of Ohio.
